WFNC'S "THE DOOBIE BROTHERS" TICKET GIVE AWAY CONTEST OFFICIAL RULES

The Station will conduct the WFNC'S "THE DOOBIE BROTHERS" TICKET GIVE AWAY CONTEST

Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest will begin at 6:00 am ET on December 09, 2019 and will run through 9:00 am, ET on December 13, 2019 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:

(i) <u>On-Air</u>: Listen to the Station weekdays from 6:00 am – 9:00 am during the Contest Period. When the Station gives "cue-to-call", listeners should call the Station at 910-864-6400. Caller five (5) to the Station, as determined by the Station in its sole discretion, will be entered to win. <u>*Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*</u> Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- 4. **Winner Selection.** On or between 6:00 am ET on December 09, 2019 through 9:00 am ET on December 13, 2019, Station will select one (1) entry for prizes by the entrant calling the Station at 910-864-6400 when the Station plays the "cue-to-call". The winning entrants will be contacted during the call and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
- 5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply

The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination.
