## WFNC "REO SPEEDWAGON" TICKET GIVE CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WFNC ("Station"), 1009 Drayton Road, Fayetteville, NC 28303, during available business hours Monday through Friday, on the Station website www.wfnc640am.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WFNC** "**REO SPEEDWAGON**" **TICKET GIVE** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. This Contest is open only to legal U.S. residents excluding Florida or New York residents twenty one (21) years or older, at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 90 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 90 days. At or around **6:00 am ET to 9:00 am ET** when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 910-864-6400. Caller # five (5) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON**
